A complete site plan showing the proposed lot, drawn to scale, including location of ALL buildings & structures (new or existing), fences, pool dimensions, depths, valves, piping, heaters, filters, drainage plan, location of electrical service lines, easements, and other related appurtenances. Application shall be returned to the City of Oregon Inspection Department along with the minimum number of construction documents plus any sets required for your records, which you want review for approval. Sets must be bound and/or stapled in a complete set. (Electrical permits may be required for all pools.)
