Sealed proposals marked “**2019 Oregon Senior Center Roof Replacement Project**” will be received at the office of the Director of Public Service, 5330 Seaman Road, Oregon, Ohio 43616-2633, until 10:00 A.M. April 30, 2019 and immediately there-after publicly opened and read aloud for furnishing the Department of Public Service:

Labor, material, tools, equipment, and supervision necessary to remove existing roofing and complete the installation of Asphalt Shingles and EPDM Adhered Roofing Systems including flashings, insulation, and appurtenances as specified herein. The bid includes 18,950 sq. ft. of roofing at the Oregon Senior Center.

A pre-bid meeting and roof inspection tour will be held at the Oregon Senior Center, located at 4350 Navarre Avenue, Oregon, Ohio, on April 17, 2019 **at 10:00 a.m.**

A bidder's bond, certified or cashier's check on a solvent bank, payable to the City of Oregon in the amount of 10% of the total amount of the bid as a guarantee that if the proposal is accepted a contract will be entered into, is to accompany the bid. There is also a requirement for the successful bidder to provide a performance bond equal to 100% of the contract.

All bids must be made on the proposal form, which, with specifications, etc., may be obtained upon application at the Office of the Director of Public Service.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof. The Council of the City of Oregon, Ohio reserves the right to waive any informalities or to reject any or all bids.
