*Monthly payments are required to be submitted if the previous year's withholding payments were over \$2399 or if any month in the previous quarter was \$200 or more.

The Reconciliation Due Date is Feb 28th for both Quarterly and Monthly withholdings, which must include ALL withholding districts in addition to non-taxing districts.
